The undergraduate students must complete 10 required credits of foreign language courses as follows:

- English (I), (II): 4 credits
- English thematic course: 5 credits
- English Test: 1 credit

English (I) and (II) are 4 credits elementary courses for the freshmen who are grouped on English competence-based to complete within two semesters.

English thematic courses are 5-credit of English courses; students are required to obtain

5 credits through 3 different thematic courses for graduation.

For the requirements of registering "English Testing", please refer to "the Regulation for Registering English Test" announced and implemented by the College of General Education.

Foreign students need approval by ILCC for taking 10 credits of Mandarin Chinese courses as alternative courses of English.

The undergraduate foreign students, exchange students excluded, must score 60 points or higher to pass Mandarin Chinese (I) and (II) before taking Mandarin Chinese (III), (IV), (V), and (VI). Students must score 60 points or higher in Mandarin Chinese (III) and (IV) before taking Mandarin Chinese (V) and (VI).
